TERMS & CONDITIONS OF PARTICIPATION

1. GENERAL COMPLIANCE & PRICING

- **Uniform Discount:** A strict uniform discount of 10% will be allowed on the printed price of all books and reading materials. Higher discounts or promotional undercutting are legally prohibited under fair guidelines.
- **Legal Material:** No books, digital mediums, or materials forbidden by law—including items violating the Copyright Act—will be displayed or sold. The Exhibitor assumes absolute, sole liability and fully indemnifies the Organiser against all legal proceedings and consequences.

2. SOUND, ADVERTISING, AND PASSAGE RESTRICTIONS

- **Audio/Visual Displays:** Exhibitors playing audio/video systems at their stalls must ensure that the decibel level does not cause any annoyance to neighboring exhibitors or visitors. The Organiser remains the sole arbiter and retains the right to cut off power to offending stalls.
- **Passage Encroachment:** No physical encroachment or extension into the walking passages is permitted. All displays, book racks, counter desks, and stocks must be completely arranged within the designated interior boundaries of the allotted square footage.
- **Unauthorized Publicity:** The distribution of loose leaflets, pamphlets, or flyers inside the Patna Book Fair premises is strictly banned. A mandatory penalty fine of ₹5,000/- will be levied on anyone found doing so.
- **Signage Restraints:** Any unauthorized banners, hoardings, standees, stickers, or digital display projections outside your designated space are banned. Violators will be charged a penalty fee of ₹10,000/- per day.

3. SPACE ALLOTMENT, WITHDRAWAL, AND CANCELLATION

- **Booking & Transfer:** The booking of space operates strictly on a first-come, first-served framework verified only upon clear realization of payment. Exhibitors are strictly prohibited from subletting, sharing, or parting with the allotted items or space to third parties.
- **Non-Refundable Policy:** Once a stall booking is confirmed, it cannot be altered, resized, or cancelled under any circumstances. No refunds or rental adjustments will be issued against current or future exhibitions.

- **Forfeiture of Space:** Exhibitors are deemed to have automatically withdrawn and abandoned their booking if they fail to take physical possession of the space within 24 hours of the fair's official inauguration. The Organiser reserves the absolute right to clear the layout and re-allot the unoccupied space to maintain aesthetic continuity.

4. TECHNICAL AMENITIES, LOGISTICS, AND SCHEDULES

- **Standard Stall Specifications (100 sqft):** Consists of a fully carpeted stall, wooden platform, 6 bookshelves, 2 chairs, 1 table, 2 tubelights, and 1 power point for computer connectivity (maximum permissible load threshold: 200 Watts).
- **Additional Logistics:** Extra furniture or custom electrical fittings can be sourced exclusively on a separate rental framework from the official event contractors. Additional electricity usage beyond the baseline threshold will be billed extra.
- **Operational Schedule:** Official possession of the stalls will be handed over to participants on Thursday, 3rd December 2026. Exhibitors will be granted security entry into the halls starting at 10:30 AM daily and must vacate the halls completely by 9:00 PM sharp every evening.
- **Fair timings : 11 am - 9 pm**

5. SECURITY AND LEGAL JURISDICTION

- **Loss & Damage:** While general perimeter security is arranged round-the-clock, the Organiser is not liable for structural damage, fire, rain damage, theft, or burglary of assets. Exhibitors are strongly advised to secure independent transit and local fire/burglary insurance cover.
- **Modification Authority:** Any of the terms and conditions outlined above may be relaxed, updated, or modified at the dynamic discretion of the Competent Authority of the Organiser, whose decision shall be ultimate and binding.
- **Legal Jurisdiction:** Any direct dispute, legal claim, or operational grievance arising out of participation in the fair will be subject strictly and exclusively to the jurisdiction of the Patna Courts.
